



## Gift Recognition Opportunities

Thank you for considering gift and recognition opportunities for Manhattan Youth’s Downtown Community Center. Every gift helps us achieve the final \$2.3 million toward our \$12.8 million goal. Leadership gifts will be recognized by listings on our Founders Wall or with Naming Opportunities that are associated with rooms and areas in the Center.

### Founders Wall

Founders Wall recognition begins at \$3,000, which may be pledged and paid over time, for up to three years. You may pay by check, credit card, debit card, bank account debit, or gifts of marketable securities. You may elect to have pledge payments automatically paid from your credit/debit card or bank account (required for monthly payments), or we will send invoices thirty days in advance of your pledge payment due dates if you do not elect automatic payments.

Founders Wall gift levels are as follows:

Supporter	\$18,000
Builder	\$12,000
Friend	\$6,000
Neighbor	\$3,000

Gift pledges may be paid over a period of up to three years. Please see examples of pledge payment schedules on the accompanying Pledge Form, and we will be happy to discuss alternative payment arrangements or gifts of negotiable securities. In an effort to keep administrative costs low, we require monthly payments be made by automatic debit from your bank account or credit/debit card.
